Recording of the meeting was started at 09:35

1. Welcome and Apologies

Cllr Hunt opened the meeting and apologies were noted.

2. Declarations of Interest - Elected Members' Protocols

- (1) Cllr Sean Morgan declared a personal interest in any matters relating to cryptocurrency/fintech as he personally owns cryptocurrency.
- (2) KB declared a personal interest in Item 7 Investment and Intervention Framework Report: Recommendations Logs, Strategic Outline Case and Project Updates because she was a Board member of UKRI's Research England; KB confirmed that she had had no part in the UKRI discussions or decisions on Strength in Places but was a member of the funding council.

3. Minutes of the meeting held on 28 November 2022

The minutes of the meeting held on 28 November 2022 were agreed as a true and accurate record of the meeting.

4. Proposed 2023/24 Joint Committee Revenue Budget

- (1) CL introduced the item and drew Leaders' attention to key elements in the report. KB noted that there had been no change following the Briefing on 16 January. She noted that there were a significant number of vacant posts and CCR were trying to address the lack of capacity in the team.

Cllr Andrew Morgan joined the meeting at 09:42

- (2) KB was asked about the ramifications of the lack of capacity; she said it was across the board at all levels, with the finance team being affected given that CCR finance was very complex, as well as investment, clusters and general

high order programme management.

- (3) Leaders agreed to accept the recommendations of the report and Cllr Hunt obtained individual votes of acceptance from Leaders in the following order:

Monmouthshire, Blaenau Gwent, Newport, Caerphilly, Cardiff, Merthyr Tydfil, Vale of Glamorgan, Bridgend, Rhondda Cynon Taf and Torfaen.

- (4) It was resolved that the CCR Regional Cabinet:

- (1) approved the Joint Committee expenditure budget of £2,923,165 for 2023/24 as set out in Table 1 of this report;
- (2) approved the proposed 2023/24 Annual Budget funded by the 10 Local Authority partner contributions as outlined in this report of £1,278,963, to meet part of the Joint Committee costs and representing 5% increase from the previous year;
- (3) approved that the balance of the Joint Committee costs of £1,644,202 be met from the Cardiff Capital Region Wider Investment Fund (namely that part of the HMT contributions referred to in this report as the 'WIF Top-Slice');
- (4) approved the proposed 2023/24 CJC transition budget of £234,481 as set out in Table 4 of this report and will be met from General Reserves held by CCRCD on behalf of the CCR Constituent Councils.

5. Joint Working Agreement – CCR Annual Business Plan 2023/24

- (1) KB introduced the report While there were two separate budgets, one integrated narrative had been prepared for the Annual Business Plan. 2023 would be an inflection point for CCR, with the second round of Gateway Reviews, which would result in a different set of options. A more comprehensive update of the funding strategy was required to ensure the fund was effective as possible.
- (2) Leaders were in support but noted that it would be important to have an early discussion to go into greater detail given the current financial situation for local authorities. The Plan should also form an integral part of CCR's quarterly reporting.
- (3) Leaders agreed to accept the recommendations of the report and Cllr Hunt obtained individual votes of acceptance from Leaders in the following order:

Bridgend, Rhondda Cynon Taf, Vale of Glamorgan, Merthyr Tydfil, Cardiff, Caerphilly, Newport, Blaenau Gwent, Monmouthshire and Torfaen.
- (4) It was resolved that the CCR Regional Cabinet:

- (1) noted and approved the proposed integrated Annual Business Plan for 2023/24;
- (2) approved the submission of the document as required to UK and Welsh Governments;
- (3) noted the initial options work being progressed across the CCR Office, Accountable Body and the S151 Officer Group, in consultation with the Investment Panel in order that a discussion paper on maximising use of available resources, is brought back to Regional Cabinet in due course for further consideration.

6. Regional Economic & Industrial Plan 2023-2028

- (1) CM introduced the item and provided a brief rationale of the Regional Economic & Industrial Plan (REIP).
- (2) Leaders welcomed the REIP and asked how the CCR could communicate with local authorities and the public in a way that the complexities were clear. CM said CCR were finalising various formats of the report as part of engagement with local authority partners, Welsh and UK Governments. Separate thought leadership pieces would also be considered as part of the communication plan. SC said that translation would be completed in February and the REIP design would be shared with key stakeholders. A press release was planned for March and copies would be distributed in London on 2 March at the formal launch of the Investment Fund. A social media campaign was also planned for March-April. The document would also be available as part of the Unleash 2023 conference. SC confirmed that local media would be included in all of the communication plans.
- (3) Leaders noted the importance of the plan for the region and consideration should be given as to how CCR disseminated the news to communities, in particular the 'fairer' and equivalence messages, which would be key. The flexibility in the plan would be key and it would be important to review it on a regular basis, as one of the region's strengths was flexibility and the way it could respond to challenges.
- (4) Leaders agreed to accept the recommendations of the report and Cllr Hunt obtained individual votes of acceptance from Leaders in the following order:

Bridgend, Rhondda Cynon Taf, Vale of Glamorgan, Merthyr Tydfil, Cardiff, Caerphilly, Newport, Blaenau Gwent, Monmouthshire and Torfaen.
- (5) It was resolved that the CCR Regional Cabinet:
 - (1) noted and approved the proposed Regional Economic & Industrial Plan attached to the report at Appendix 1;
 - (2) approved the submission of the document for further consultation as required to UK and Welsh Governments.
